_____ **Cancellation Policy:** I, the undersigned, do understand that if at any point I terminate enrollment at N-Step Dance Center, I need to submit a written notice 30 days before cancellation. I also understand that I am responsible for tuition up to the last day of enrollment. If I do not submit a 30 day notice I am still responsible for tuition until one is given and/or the 30 days is up.

_____ **Refund Policy:** I, the undersigned, do understand that MONIES ARE NON-REFUNDABLE AND NON-TRANSFERABLE and there are no exceptions!!! Any payments for costumes, competition fees, tuition, conventions, choreography, etc., are non-refundable under any circumstance. You also lose rights to any costumes that you have paid for or put a deposit on. If your child decides to leave the program, or is asked to leave the program, you will not be reimbursed for any deposits or payments made.

_____ **Tuition:** I understand that tuition is based on the classes per year and not the number of weeks in a month. Therefore, tuition will be the same each month regardless of whether it is a 3, 4 or 5 week month. Any missed classes are my responsibility and are non-refundable (this includes, but is not limited to illness, vacation, other extracurricular activities, etc.). I understand that these classes may be made up in a similar class during the week.

_____ **Discard Policy:** I understand that N-Step Dance Center reserves the right to refuse business to anyone. I understand that the studio reserves the right to cancel the enrollment of a dancer for the following reasons: non-payment or excessive late payment of fees, not observing the rules and/or policies of the studio, physical and/or verbal abuse of staff or children, by a parent or child.
